Moreover, the parent / guardian / custodian / legal representative states that he / she has explained to the minor guest the full content of the Contract and the House Rules, especially the risks inherent in the activities, as well as the conduct he / she must exhibit during the participation in the Cyberjump activities.

In my capacity as parent / custodian / guardian / legal representative, I hereby declare that I fully understand the Contract and the content of the House Rules and undertake to observe thereto. The parent / custodian / guardian / legal representative of the minor guest(s) hereby declares that he / she has obtained the consent of the other parents regarding their permission to participate in all Cyberjump activities by executing this Declaration.

Furthermore, I hereby declare that I irrevocably waive any and all claims against Cyberjump or any of its employees (including owners, directors, employees, volunteers, coaches, agents, equipment suppliers and insurers) in respect of injury, damage or death.

**1. Acceptance of Cyberjump Bucharest**

I hereby confirm that I have reviewed, read, and I hereby accept the General Terms of Business of the Operator - CYBERJUMP RO S.R.L. - related to the Cyberjump Trampoline park Bucharest.

**2. Acceptance of Cyberjump House Rules**

I hereby confirm that I have reviewed, read, and I hereby accept the House Rules of Cyberjump Trampoline park Bucharest. I hereby undertake to use the Cyberjump Trampoline park Bucharest only in accordance with the House Rules and in accordance with its designation in line with my personal physical and mental abilities.

**3. Stable physical and mental status**

With total awareness of my liability I hereby declare that I am not under influence of alcohol, drugs, narcotic drugs other mind-altering substances and that I do not suffer of any disease that would hinder me in the use of the park in accordance with its designation or that would cause disproportionate danger to me, third persons or to the Cyberjump Trampoline park Bucharest.

Furthermore, I hereby declare that I have the physical and mental capacity required for the responsible use of the Cyberjump Trampoline park Bucharest, in particular, I have the appropriate discipline, self-assessment and risk assessment.

In this respect, I hereby declare that I / the minor:

- I have full physical and mental capacity to participate in all of Cyberjump's activities without any help or assistance;
- I am aware that these activities require a certain degree of skill and physical coordination;
- I do not take any prescription drugs or other medication or substances that could affect my ability to participate in activities;
- I do not have a physical or mental disability that could affect my ability to participate in the activities, or if I have such disabilities, they have been or are being successfully treated, so there is no foreseeable risk;
- I hereby undertake any and all risks related to all medical conditions (for example: asthma, diabetes, anaphylaxis, heart disease);
- should medical authorization be required for carrying out the activities, I hereby undertake to obtain it and to present it before participation;

**4. Further use instructions on site**

I acknowledge that some of the games & equipment may have additional instructions on site. I undertake to look out for, read and comply with such additional instructions.

**5. Acknowledgement of dangers; use at own risk, bearing of damages**

I am aware of the fact that the use of Cyberjump Trampoline park Bucharest itself bears accident risks and bears increased accident risk in case I am overestimating my personal physical and mental abilities and thus do not use the park in accordance with its designation. I undertake to avoid any disproportionate danger. I undertake to report any actions of third parties causing disproportionate danger. I accept using the games & equipment at my own risk. I understand and accept that the liability of the operator of the Cyberjump Trampoline park Bucharest may only arise in case the condition of the games & equipment does not meet the regulations pertaining to their safe and designated use. In particular, the operator is not liable for the actions of other visitors. I will report and reimburse any damages caused by me.

**6. Assumption of liability as guide**

I hereby declare and confirm I am obliged to supervise the above listed persons and I acknowledge that as an adult escort I am liable for the persons listed above.

**7. Observance of instructions**

I undertake to observe the instructions given by the Cyberjump Trampoline Bucharest team in written or oral form at any rate. I accept that in case of violation of the house rules or not following any of the instructions I may be expelled from the Cyberjump Trampoline park Bucharest without any ticket fee reimbursement or other compensation.

**8. Administration of claims**

I have understood and accept that I am obligated to report any damage claims on one hand immediately on site (next to taking an accident minutes), on the other hand by determining and quantifying my claims within six months in writing, for liability insurance reasons.

**9. Declarations in the name of the accompanied and third persons**

I hereby declare that I am authorised to assume the above-mentioned obligations also in the name of the above-mentioned persons. In case the consent or proxy of any parent(s) is necessary, I have in my own interest obtained such consent/proxy in advance. Thus, I assume the above-mentioned obligations also in the name of the above mentioned persons.

I hereby declare that I irrevocably waive any legal action or claim against the Operator or any of its employees in respect of injury, damage or death.

The obligations resulting from this Declaration are deemed to be fully undertaken by me, and non-compliance with any provision of the House Rules shall be considered as a default on my behalf, thus CYBERJUMP RO S.R.L. being exempted from any and all liability.

This Declaration is valid for throughout the entire participation in the Cyberjump activities of carried out after its execution.
